

METHODS OF BIBLE STUDY

- 1) Inductive pulling out the facts

 define text...who? what? where? when? why? how?

 uses observation, interpretation, and application
- 2) Deductive starts with a premise

 most topical studse-, sometimes verses are
 taken out of context, tendency to gravitate to topics
 most comfortable with
- 3) Springboard starting point for study based on an opinion **Inductive Bible Study**

***ALWAYS BEGIN WITH PRAYER*

OBSERVATION

WHAT DOES THE TEXT SAY?

Read the text many, many times

Record first impressions

Record words and phrases that are repeated(lists)

INTERPRETATION

WHAT DOES THE TEXT MEAN?

Interpret literally

Study in context

Let Scripture interpret Scripture

Exhaust the text first(before using any helps)

APPLICATION

HOW SHOULD I RESPOND?

Examples to follow? Promises to believe?

Sin to forsake? Commands to obey?

Errors to avoid? Actions to take?

FORMULATING INDUCTIVE QUESTIONS

Writing inductive questions is a skill that will improve with practice. You must begin with a thorough study of the text you are studying. As you ask these questions, the class will find what you found in your own study. A quick study will lead to a brief surface question and answer period in your classroom that will not lead to the strong truths found in God's Word. You want to do a thorough study of the passage that will encourage the children to knowing God and applying His truths to their lives. This will take time and effort on your part, but oh how sweet the fruit! You also want to encourage children to be imitators of the Bereans..."These were more noble than those in Thessalonica in that they received the Word with all readiness of mind, and searched the scriptures daily, whether those things were so." Acts 17:11

- 1) Study for yourself firs, then otherst:
 What does God want to teach me?
 What can we all learn for our lives?
- 2) Look over your lists and note any points you want to include.
- 3) Determine the main theme of the passage. Your questions should lead to a discovery of the major points and an application to individual lives.
- 4) Your preparation has already revealed the stream of thought and your questions will reflect that.
- 5) Start with overall questions (passage as a whole)
- 6) Through your questions, you will be able to go through the passage in sequence
- 7) Prepare three types of questions:

Observation - facts only

Intepretation - meaning of facts

Applications - response to the meaning of facts

Charting is a very useful tool when studying inductively

MARK 6:45-52

- 45 And immediately He made His disciples get into the boat and go ahead of Him to the other side to Bethsaida, while He Himself was sending the multitude away.
- 46 And after bidding them farewell, He departed to the mountain to pray.
- 47 And when it was evening, the boat was in the midst of the sea, and He was alone on the land.
- 48 And seeing them straining at the oars, for the wind was against them, at about the fourth watch of the night, He came to them, walking on the sea; and He intended to pass by them.
- 49 But when they saw Him walking on the sea, they supposed that it was a ghost, and cried out; 50 for they all saw Him and were frightened. But immediately He spoke with them and said to them, "Take courage; it is I, do not be afraid."
- 51 And He got into the boat with them, and the wind stopped; and they were greatly astonished, 52 for they had not gained any insight from the incident of the loaves, but their heart was hardened.

These are sample questions. Your questions will vary depending on the age you are teaching and the passage you are teaching. This method does get easier with practice!!! Always encourage the children to look at the Bible passage when answering the questions. Encourage more than one child to answer when appropriate. Ask the children to think up questions of their own. As you use the inductive study method in your classroom, the children will start to use this method by themselves. You will be amazed at the fruit of your effort, and will be blessed by seeing the spiritual growth of the children!
